It is important to note that all evaluation include the following:

- •The taking of a detailed case history
- Counseling (according to the patients emotional needs)
- Determination of options for ongoing management following assessment
- Consideration and implementation of appropriate treatment
- · Administration of standardized clinical assessment or an empirical clinical assessment
- Assessment of the ability of the patient to communicate at the persons school or workplace
- Evaluation and analysis of the assessment results
- Time spent writing an evaluation report

(*Bilingual reports are very extensive and require administering assessments in both languages).

Assessment of current skill level is done using parent/caretaker/client interview, standardized and criterion-referenced evaluation tools, observation of social interaction and communication skills, and clinical analysis of speech and language samples. Results of the evaluation are given verbally and explained at the time of the assessment, or in a follow up phone call. If you would like a written report, the cost is \$30 to print/\$10 to email. The clinician will make a recommendation for frequency of therapy. Appropriate goals are developed with the client's input to focus on aspects that will most benefit overall communication and align with the client's priorities and values. Printed resources will be provided and reviewed at the time of the visit.
